2. Content and purpose of the briefing

3. Legislation that is the primary basis for data management

- CVIII of the year. Act on Certain Issues of Electronic Commerce Services and Information Society Services (Eker TV)

4. Changing Data Management Guide

The Data Controller may unilaterally amend this Data Management Information. The current Data Management Bulletin is available on the Website. In order to be aware of the modification and to review it, you must have Internet access and regularly check the Website.

5. Users, minors

Customer: The User enters into a contract with the Data Controller by the order. You may use the services provided by the Data Controller on the Website based on your personal data provided during the Order.

Special rules to complete the Order:

- When ordering, you must provide the required information and
- By providing the required data voluntarily, you declare that you have read, understood and understood this Data Management Guide;
- You can only place an order if you have reached the age of 18 years.

6. Special Provisions for Minor Users

A minor may give his / her own consent after reaching the age of 16, without the consent or subsequent approval of his / her legal representative for the validity of his / her legal declaration. The Service Provider is not in a position to verify the eligibility of the contributor or to become aware of the contents of the statement of the legal representative, so the User or his / her legal representative warrants that the consent is in compliance with the law. In the case of using the Service, the Service Provider considers the proper consent of the legal representative as given.

7. How to accept and understand if you accept the Privacy Policy

If you place an order on paper, email, or otherwise, it is important that we treat your data in accordance with this prospectus.

8. Data Treatments

Billing related data management

- whose data we handle: Details of users who place an order for a payment service. (Name, address, email address.)

- Purpose of data management: To keep accounting records.

The provision of data is based on a legal obligation and is mandatory. If you do not provide this information, we will not be able to process your order.

- Deletion of data: Deletion of these data will be automatic upon expiry of the legal deadline and not possible before the deadline expires.

- Legal basis for data management: The legal basis for data management is the fulfillment of the legal obligation to the Data Controller under the Accounting Act (Section C (1) - (2) of Act C of 2000, Article 6 (1) (c) GDPR).

- Duration of data processing: 8 years from the date of issue of the invoice.

- Data transfer, forwarding: Server and hosting provider and accountant

9. Access to data, data security measures

In accordance with Article 32 of the General Data Protection Regulation (GDPR), the data controller shall make every effort to ensure the security of the data and to make the necessary technical and organizational arrangements.
